To the Members of M/s North Star Fixtures & Furniture Private Limited Report on the Financial Statements

We have audited the accompanying financial statements of **M/s NORTH STAR FIXTURES & FURNITURE PRIVATE LIMITED** ("The Company"), which comprise the Balance Sheet as at March 31, 2026, the Statement of Profit & Loss account for the year then ended, and a summary of significant accounting policies and other explanatory information, which we have signed under reference to this report.
